Shadananda Municipality invites electronic bids from eligible bidders for the *Construction of Lamukhola Water Supply Project, Shadananda Municiplaity* under National Competitive Bidding Single Stage Two Envelope Bidding procedures. - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 43.25 Millions
- Minimum Work experience of similar size and nature: *One Water Supply Project with Minimum Value of NRs.* 11.55Millions

- Electronic bids must be submitted to the office of Shadananda Municipality, Dingla Bhojpur by through PPMO's e-GP system www.bolpatra.gov.np/egp before 12:00 Hrs. on 21th November, 2023. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00Hrs on 21th November, 2023 at the office of Shadananda Municipality, Dingla Bhojpur Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, \amounting to a minimum of NRs. 8,50,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 6. Other related rules and regulations are as per Public Procurement Act-2063 and Public Procurement Regulations-2064 following all revisions and other prevailing law of Nepal.
